#### **Before Coming to Campus**

All members of the Pacific Community will be required to complete an updated online training course. Link will be provided soon.

## Daily Health Screening

Students are required to conduct a daily self-screening to assess their risk of being COVID-19 positive or being exposed to another person who is COVID-19 positive.

The screening app has been updated to ask your vaccination status if the university does not have a record of you being fully vaccinated. Knowing your vaccination status will assist the university to better manage the health and safety of our community. All information is confidential.

The screening tool is not intended to diagnose COVID-19, but to identify possible signs of the virus and to raise awareness of wellness. This daily screening includes questions about symptoms such as a fever or cough, travel history or contact with someone who is COVID-19 positive. If any questions are answered in the affirmative, the student or employee will receive an email or text with further instructions. If all questions are answered negative for risk, the application generates a "You Pass" + QRR email for Sacramento and Stockton.

For the San Francisco campus ONLY, the application generates a bar code for entrance to the building if all questions are answered as negative for risk. Automated temperature screening kiosks are in place to measure the temperature of all individuals entering the building.

#### COVID-19 Vaccination information for students

All students will be required to be <u>fully vaccinated</u> before returning to campus by:

- July 6, 2021 for San Francisco Campus
- July 15, 2021 if participating in <u>Back to Pacific: Ready, Set, Roar!</u>
- Aug. 1, 2021 for the Stockton and Sacramento campuses

If you have been fully vaccinated at one of Pacific's COVID-19 vaccine clinics, we already have recorded this information in the university's secure medical records system. You do not need to do anything at this time.

If you have been fully vaccinated somewhere other than one of Pacific's COVID-19 vaccine clinics, please upload your COVID-19 vaccination information into the <u>University of the Pacific Health Portal</u> (Pacific ID login required) under the Medical Clearances tab. All data and information is confidential and protected under <u>HIPAA guidelines</u>.

# Fully Vaccinated is defined as:

- 2 weeks after a second dose in a 2-dose series, such as the Pfizer or Moderna vaccines, or
- 2 weeks after a single-dose vaccine, such as Johnson & Johnson's Janssen vaccine

If an individual does not meet these requirements, they are NOT fully vaccinated. All <u>precautions</u> provided by the CDC should be followed until fully vaccinated.

#### COVID-19 Vaccine Exemption

If a student chooses to not be vaccinated, for health or religious reasons, he/she/they must complete a declination form (pdf) and submit to Pacific's Student Health Portal (Pacific ID login required). Students with vaccine exemptions will be required to follow more stringent health and safety protocols specifically designed for unvaccinated individuals.

To upload declination form:

- 1. Log into the **University of the Pacific Health Portal**
- 2. Click Downloadable Forms Tab
- 3. Submit the declination form under additional Immunization Records tab

### Testing Information for Students

The university will continue to follow state and county surveillance testing guidelines that will vary depending on academic programs, on-campus residency, and COVID-19 activity in the campus' county. Vaccinated individuals will no longer be expected to participate in surveillance testing unless symptomatic.
